### Why the consultations?



To gather evidence from target audiences on the results achieved by EMFF and EMFAF support in their respective programming periods and to identify factors contributing to effectiveness, efficiency, relevance, coherence and EU added value.

#### Commission aims to:

- (i) assess if the two Funds have achieved, or are in the course of achieving, their objectives and;
- (ii) determine the lessons learnt (including in terms of crisis response), which may be relevant in the implementation of EMFAF in 2021-2027 and for the post-2027 period.



## Consultations on fisheries and maritime activities funding programmes



The first consultation (EMFF ex-post evaluation) aims to gather evidence and different perspectives on the management and use of the funds from various actors involved or interested, such as individuals, the fisheries and the maritime sectors, non-governmental and other organisations, and national administrations from Member States.

The second consultation (EMFAF mid-term evaluation) will include a questionnaire that will be published in the coming weeks and will seek feedback from the main actors involved or interested in the management and use of the funding provided through EMFF and EMFAF from 2014 until 2024. EMFAF

#### EU Maritime and Fisheries Fund (EMFF) 2014-2020 – ex-post evaluation
